



## ***Policies***

### ***Reservations, Rates, & Payments***

- Every guest and reservation is important. If you must cancel your reservation, please call us at least 2 (two) days prior to your arrival date to cancel your reservation to receive a full refund. If you cancel with less than two (2) days notice, we can rebook your stay, or issue a partial refund.
- Rates and policies are subject to change and may vary. A seven (7) day cancellation notice is required for some holidays, special events, and whole campground bookings.
- Payments must be made in advance or upon arrival.

### ***Accommodations & Activities***

- CHECK-IN time: 1:00 PM.
- CHECK-OUT time: 11:00 AM.
- QUIET HOURS: 10 PM to 8 AM.
- SPEED LIMIT: 5 MPH.
- VEHICLES: Sites 1-4, 8, 10, 11 & 15 accommodate ONE RV and TWO other vehicles. Sites 5-7, 9, 12-14 accommodate ONE RV and ONE other vehicle. All must be clean and in good condition regardless of age.
- Sites must be kept clean. There is a DUMPSTER for bagged trash or boxes.
- Use of a SEWER HOSE CONNECTOR (“donut” or “L”) is required.
- Fires are allowed only in FIRE PITS or GRILLS that are raised and contain the fire.
- The CODES for the Bridge (laundromat, bath, and fitness room) or WiFi must not be given out to anyone outside of your party.

- CHILDREN under 12 must be accompanied by a parent or guardian while outside your RV at all times.
- Two PETS are allowed per RV and must not disturb other guests. Pets outside must be on a leash, under control, and not left unattended. Pet owners are responsible to immediately pick up after their pets. Plastic bags and bins are available for waste.
- Use of GENERATORS is prohibited, except during a power outage.
- WASHING or CHANGING OIL of vehicles in the park is prohibited.
- SMOKING is prohibited inside the Depot (office, cafe, and museum) and the Bridge (laundromat, bath, and fitness room).
- Do unto others as you would have them do unto you.
